In compliance with the requirements of 15 Pa.S. §7316 (relating to articles of incorporation) the undersigned desiring to be incorporated as a nonprofit corporation, hereby certifies (certify) that it is incorporating under the act of November 15, 1972, No. 271, and that:

1. The name of the corporation is Lancaster County Bible Church.
2. The location and post office address of the initial registered office of the corporation is 309 Lebanon Road, Manheim, Pennsylvania 17545. (36)
3. The corporation is incorporated under the Nonprofit Corporation Law of the Commonwealth of Pennsylvania solely and exclusively for religious purposes, namely to provide an evangelical, Bible-teaching and preaching ministry to be accomplished through the assembling of God's children for Bible reading, prayer, worship and work; the administration of the New Testament ordinances of the Lord's Supper and Baptism; the maintenance of a preaching and teaching ministry of the Gospel of the Lord Jesus Christ both at home and abroad unto the salvation of souls and the spiritual growth of believers.

The corporation does not contemplate pecuniary gain or profit, incidental or otherwise.

4. The term for which the corporation is to exist is perpetual.
5. The corporation is organized upon a nonstock basis.
6. Upon dissolution of the corporation, after paying or making provision for the payment of all liabilities of the corporation, it shall dispose of all of the assets of the corporation exclusively for the purposes of the corporation, in such manner, or to such organization organized and operated exclusively for religious as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 as the Board of Elders may determine. Any assets not disposed of as set forth above shall be disposed of in accordance with the order of the Court of Common Pleas of Lancaster County, for the purposes of this corporation and to exempt organizations as above set forth.

- 7. The governing body of the corporation shall be known as the Board of Elders.
